Treasurer's report: The CD current balance is \$9,323.71, the second CD balance is \$4,175.37, and the checking account current balance is \$5,664.28, for a total of \$9,163.36. To date, the Snack Shack has a profit of \$1,634.50.

Sue motioned to accept the Treasurer's report, seconded by Connie. All in favor.

Old Business

Christmas ornament fundraiser update – Sue shared the proof of the ornament. It is two dimensional and the cost will be \$10.00 each. Unfortunately, the minimum order is 250 ornaments, not 150.
